Purpose

This policy applies to all healthcare professionals working for Clinical24 Staffing Limited who provide nursing care to private patients in their own homes within Northern Ireland.

Statement

Clinical24 Staffing Limited is committed to providing safe, effective, and person-centred nursing care to private patients in their own homes. This policy outlines the process for assessing, planning, implementing, and evaluating nursing care to ensure the delivery of high-quality services.

Procedure and Guidance

Definitions

Private Patient: An individual receiving nursing care services privately and residing in their own home.

Care Plan: A documented plan that outlines the nursing care to be provided to the private patient in their own home.

Implementation: The delivery of nursing care based on the established care plan.

Evaluation: The systematic and ongoing review of the effectiveness and outcomes of nursing care provided to private patients in their own homes.

Policy Guidelines

Assessment:

- Conduct a comprehensive initial assessment of the private patient's physical, mental, and social health needs.
- Assess and document the patient's current medical conditions, allergies, medications, and relevant medical history.
- Involve the private patient and their family/carers in the assessment process to gather their input and preferences.
- Identify any risks or potential challenges associated with providing nursing care in the patient's home environment.

Planning:

- Develop an individualized care plan based on the assessment findings, including specific nursing interventions and goals.
- Ensure the care plan is regularly reviewed and updated to reflect the changing needs and preferences of the private patient.
- Involve the private patient, their family/carers, and other healthcare professionals in the care planning process, fostering a collaborative approach.

Implementation:

- Deliver nursing care according to the established care plan, while considering the privacy, dignity, and cultural needs of the private patient.
- Administer medications, perform treatments\procedures, and provide support as outlined in the care plan.
- Continuously assess and manage pain levels, hygiene needs, and nutritional requirements of the private patient.
- Promote effective communication and provide education to the private patient and their family/carers regarding their condition, treatment, and self-care techniques.

Evaluation:

- Regularly evaluate the effectiveness of nursing interventions by assessing the private patient's progress and outcomes.
- Modify the care plan as needed based on the evaluation findings, ensuring it remains up-to-date and relevant.
- Seek feedback from the private patient, their family/carers, and other healthcare professionals involved to continuously improve the care provided.
- Engage in reflective practice and ongoing professional development to enhance nursing care delivery.

- Maintain accurate, comprehensive, and confidential records of all assessments, care plans, interventions, and evaluations conducted for private patients.
- Record any changes made to the care plan, including the rationale for modifications.
- Ensure documentation adheres to relevant legal and regulatory requirements, including data protection and confidentiality.

Training and Education:

- Provide regular training and education sessions for healthcare professionals delivering nursing care to private patients in their own homes.
- Ensure staff members are knowledgeable in relevant policies, procedures, and best practices related to the assessment, planning, implementation, and evaluation of nursing care in home settings.

Quality Assurance:

- Regularly monitor and audit the implementation and adherence to this policy to identify areas for improvement.
