- Upon approval, the procedures will be disseminated to all relevant healthcare professionals employed by or contracted to Clinical24 Staffing Limited via an accessible and centralized platform or system.
- Clinical24 Staffing Limited will ensure that healthcare professionals receive appropriate orientation, education, and training on the clinical nursing procedures to ensure their understanding and competence in their implementation.

Adherence to Clinical Nursing Procedures

- All healthcare professionals employed by or contracted to Clinical24 Staffing Limited are required to adhere to the approved clinical nursing procedures during the provision of care.
- Deviations from the clinical nursing procedures should be reported and documented as per the Clinical24 Staffing Limited's incident reporting and management policy.
- Any proposed modifications or updates to the clinical nursing procedures should be communicated to the committee responsible for their development for review and consideration.

Guidance

Healthcare professionals should familiarize themselves with the clinical nursing procedures relevant to their practice area and ensure they are up to date with any revisions or updates.

In situations where evidence-based clinical nursing procedures are not available or applicable, healthcare professionals should exercise professional judgment, seek expert consultation when necessary, and document their rationale for diverging from established procedures.

The clinical nursing procedures should be regularly reviewed and updated by the multidisciplinary committee to ensure alignment with current best practices and standards of care.
