To advise on the process for the international recruitment of workers by Clinical24 Staffing Limited.

### Statement

Clinical24 Staffing Limited international recruitment is conducted via the ICG Medical Limited's Project Delivery Manager.

## **Recruitment Activities**

With a freedom of movement, any application or interest received from an individual directly to our permanent overseas recruitment team is treated fairly as we are an equal opportunities employer, which means that we are committed to providing equality of opportunity in employment to all persons.

When recruiting on behalf of NHS organisations we will work with them to agree a process that works for them and the nurse(s) this will include who conducts the interview after initial screening

When we recruit, we make sure we are within the following recommended by Equality and Human Rights Commission:

- Follow the good practice recommendations of the codes of practice and other guidance issued by the Equality Commission.

- Select the best person for the job in terms of qualifications and abilities.

Accurate information is provided to all international applicants about the type of jobs in which they might be placed, and this includes but is not exclusive to:

- Health and Social Care and independent sector recruitment.
- Minimum terms and conditions.
- Job and person specification.
- NMC adaptations requirements.
- Professional associations and trade unions.
- NMC registration process.
- Geographical area and cost of living to which they will be living.
- other costs which maybe incurred e.g. uniform, accommodation and transport costs.

Recruitment and selection of internationally recruited nurses includes pre-employment health assessment as dictated by the client for whom recruitment is occurring.
