Purpose

This policy applies to all staff members, including agency nurses and healthcare professionals, and ensures that requests for private nursing care are handled promptly, efficiently, and in accordance with legal and ethical standards.

Statement

Clinical24 Staffing Limited Nursing Agency is dedicated to providing high-quality nursing care to our clients. Our Responding to Requests for Private Nursing Care Policy outlines the procedures and guidelines for responding to requests for private nursing care services.

Procedure and Guidance

Definitions

• **Private Nursing Care:** Private nursing care refers to the provision of nursing services to clients on a private basis outside of the agency's usual contracted services. This can include services such as private home care, private hospital care, or specialized nursing care requested by an individual or their representative.

Client Requests for Private Nursing Care

- **Assessing the Request:** When a client or their representative requests private nursing care, the nursing agency will thoroughly assess the client's needs, requirements, and eligibility for such services.

Staffing Considerations
